

Notice of Availability of a Draft Environmental Assessment for the Proposed Midfield Development Program and Associated Improvements at John Glenn Columbus International Airport; Notice of Determination of Adverse Effect Under Section 106 of the National Historic Preservation Act; and Notice of Public Hearing

ACTION: The Columbus Regional Airport Authority (CRAA) is preparing an Environmental Assessment (EA) to address the proposed Midfield Development Program (MDP) and associated improvements at the John Glenn Columbus International Airport (CMH). The EA is being prepared to comply with the National Environmental Policy Act of 1969. The documentation includes information related to a Federal Aviation Administration (FAA) determination of adverse effect under Section 106 of the National Historic Preservation Act of 1966.

PUBLIC HEARING: The CRAA will conduct a Public Workshop and Public Hearing related to the EA for the proposed improvements at CMH. The Workshop/Hearing will be held from 6:00 p.m. to 8:00 p.m. on April 26, 2017 at the Gahanna Senior Center, 480 Rocky Fork Blvd., Gahanna, OH, 43230; and from 6:00 p.m. to 8:00 p.m. on April 27, 2017 at the Days Inn Columbus Airport at 750 Stelzer Road, Columbus, OH, 43219. The same information will be presented at both workshops/hearings. Comments received at the Public Hearing will become part of the final EA document to be submitted to the FAA for review. Airport staff and consultants will be available to answer questions and provide information regarding the Draft EA and proposed action at CMH.
